To represent us when dealing with the customs administration under the terms of this direct representation in conformity with Article 18 of the Union Customs Code (EU regulation n° 952/2013) and decree of 13th April 2016, relative to customs representation and registration of customs representatives:

- ✓ to sign, in our name and on our behalf, or in the name and on behalf of our principal under the delegation of authority, all import and export customs declarations
- ✓ to perform all acts relating thereto
- ✓ to present documents and goods and assist during customs checks (including sample takes)
- ✓ to represent us when dealing with other administrative authorities and any other relevant organization in order to perform the entrusted operations (sanitary, phytosanitary, veterinary, excise)
- ✓ to execute operations under special procedures (temporary import, temporary export, inward processing, outward processing, end-use etc...)
- ✓ to authorize the use of *our customs credits (1) and /or * the representatives customs credits (1) for the purpose of carrying out the operations specified above (*delete as appropriate)
- ✓ to settle on our behalf the duty and/or taxes relating to customs declarations and acts referred to above
- ✓ to accept any reimbursement and retrieve all certificates and to provide a receipt in both cases

If your company has been delegated a mandate by your importer/exporter principal, it is your responsibility to keep copies of the main mandates. It is your duty to produce them at DESTOCK FCL's first request, to enable us to meet the requirements of customs and health controls. DESTOCK FCL cannot be held responsible for failure to produce the principal mandate to the administrative authorities.

As a reminder, any designated agent may sub-delegate his mandate to another person, provided that this is not prohibited by the principal mandate.
